COURSE BACKGROUND & OBJECTIVES:

Devolved Units (Counties) in Kenya have faced frequent criticisms about their policy direction and legislative processes. Such criticisms are grounded on perceptions that most Devolved Units lack clarity on their functions and that County Assemblies

exercise their legislative and oversight role in an uncoordinated and chaotic manner. Accordingly, it is important that those working on devolution understand and reengage with policy-making and legislative processes deeply.

This course is designed to provide participants with opportunity to reengage with practical knowledge and skills on policy-making and legislative (including oversight) processes in counties. Participants will be taken through hand-on training on policy-making and coordination, and attendant legislative processes. Participants will also be taken through the constitutional, statutory and policy underpinnings governing Devolved Units in the Constitution 2010, and the implementing necessary constitutional, legislative and policy instruments. It is also important to understand the socio-political place of all institutions of County Governments and the indispensable place of inter-governmental relations (with other counties and the national government) in policy-making and legislation. The training will also review the place of regional development blocks in policy-making and legislation in Devolved Units.

FACULTY:

The Kenya School of Law has assembled a highly experienced Faculty comprising of seasoned practitioners, government officials, and Professors to deliver this course.

CERTIFICATION:

Certificates of participation will be issued at the end of the training.
