DEFINITION OF TERMS

In this Policy, unless the context otherwise requires-

"Act" means the Kenya School of Law Act, 2012;

"school" means the Kenya School of Law, including all its campuses;

"student" means a person admitted and registered at the School to undertake a course of study;

"committee" means the Student Welfare Committee;

"parent" means biological father or mother or lawful guardian;

"Board" means the Board of The Kenya School of Law

1. PURPOSE

This Policy sets out the framework for the development and implementation of guidelines for student welfare.

2. GENERAL POLICY STATEMENTS

- a) The Board is committed to facilitating and promoting student welfare.
- b) This policy serves as a reference and guideline document upon which the management of student welfare will be based.
- c) In implementing the policy, the School shall formulate strategies to ensure sustainability of student welfare.
- d) The student welfare operations of the School shall be coordinated by the Student Welfare Committee.
- e) The School shall involve stakeholders in the development and review of the student welfare policy.

3. STUDENT WELFARE COMMITTEE

3.1 Establishment and Composition

There is established a Student Welfare Committee which shall consist of-

- a) a chairperson;
- b) two lecturers;
- c) four student representatives;
- d) a representative of the sports office;
- e) the Students Welfare and Counselling Officer who shall be the secretary.

3.2 Functions

The functions of the Committee include:

- a) advising the Director on all matters relating to student welfare;
- b) prepare an annual work plan for student welfare activities;
- a) organizing and coordinating student welfare activities;
- b) developing periodic guidelines for utilization of the funds available for student welfare;
- c) establishing welfare linkages with other institutions;
- d) developing guidelines for implementation of student welfare activities;
- e) engaging stakeholders in the development, implementation and review of this policy;
- f) monitoring and evaluating the implementation of this policy; and
- g) preparing and submitting to the Director periodic reports on the implementation of this policy.

4. STUDENT WELFARE PROGRAMMES

- 4.1 The student welfare programmes will cover continuing students and will include:
- a) career advisory and guidance;
- b) student leadership;
- c) compassionate support;
- d) hospitality;
- e) safety and security;
- f) health and counseling;
- g) transport;
- h) sports;
- i) spiritual welfare;

- j) social welfare.
- k) endowment
- 4.2 The Committee shall develop guidelines for implementation of the programmes under paragraph 4.1

5. IMPLEMENTATION AND REVIEW

- a) The Director is responsible for implementation of this Policy.
- b) This Policy shall be reviewed at least once every five years.
- c) A review of this Policy shall take into account
 - i. new and emerging trends;
 - ii. the strategic plan of the School;
 - iii. changes in social, economic, political and technological environment; and
 - iv. recommendations of the Student Welfare Committee.

6. MONITORING AND EVALUATION

The Deputy Director ATP & PTP shall in consultation with Student Welfare Committee, develop monitoring and evaluation tools for effective implementation of this policy.
